Application Instructions

When applying DuPont® Acelepryn® Insecticide 0.067% with Shaw's® Turf Food 33-0-12 you should not apply when the soil is saturated with water because adequate distribution of the active ingredient vertically in the soil profile cannot be achieved under this condition. High levels of control can be achieved when applications are made preceding or during the egg laying period. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pest, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.
