Shaw's 30-0-4 with Ronstar® is a preemergent herbicide with fertilizer combination that controls a variety of annual broadleaf weeds and annual grass weeds, including crabgrass, goosegrass and annual bluegrass (Poa annua). It controls weeds through their shoots rather than their roots, so it won't harm turfgrass roots in the process. In fact, Ronstar can be used for weed control even in areas that may need to be sprigged or where turfarass roots are already weakened due to pest, mechanical, winterkill or other damage. Also, because Ronstar is in a different class of chemistry from DNA (dinitroaniline) products, it is effective against DNA-resistant goosegrass. This product contains 100% of nitrogen from Polymer-Encapsulated Urea (SurfCote-4). SurfCote-4 is controlled release technology that delivers a more uniform and predictable release of nutrient for a period of up to 120 days. For Extended Release Technology, trust in SurfCote-4 to deliver the lasting performance you demand. This product also contains Gro-Gard, a proprietary blend of two bio-active amino acids and co-factors; it activates key amino acids that help regulate

## Application Instructions

Apply uniformly through calibrated commercial application equipment. Can be applied anytime of the year prior to weed seed germination to both newly transplanted and established actively growing or dormant ornamental plants where both weed control and fertilization is desired. Rainfall or overhead irrigation (¼ inch water) will improve weed control activity. Do not mix into soil. Disturbing or cultivation the soil after treatment may reduce weed control.
